Filippo Maria Carinci Fellowship in Aegean Prehistory 2024

The Ca' Foscari University of Venice intends to facilitate research collaboration with public and private entities, and the Department of Humanities of the Ca' Foscari University of Venice promotes research in many fields, including archaeology, history, philology, literary studies, and art history. The Department, in collaboration with the Centre of Archaeological Studies in Venice (CeSAV), will host **one Visiting Fellow** in Aegean Prehistory during the academic year 2024/2025, funded through a generous donation by the Institute for Aegean Prehistory (INSTAP) in honour of Professor Filippo Maria Carinci, for research activities focused on Aegean Prehistory at the University.

Art. 1 – Eligibility

The Visiting Fellowship is open to post-doc scholars (holding a PhD and having max. 15 years research experience post-PhD at the closing date of the application), who will be working on a project related to the field of Aegean Prehistory as specified in INSTAP's remit (i.e. from the Neolithic period to 776 BC). The Visiting Fellowship is open to both overseas and UK/EU residents, with no permanent position at the time of the application.

Art. 2 - Duration of tenure

The duration is a minimum of 6 and up to a maximum of 8 continuous weeks during term time in a normal academic year (between September and the beginning of June, excluding Christmas and Easter Vacations). Art. 3 - Financial and other arrangements

The Visiting Fellowship carries an honorarium of **5.400,00 euros**, which should also be used towards travel and accommodation expenses. The University will offer help and advice on travel to and accommodation in Venice, but related expenses will be met by the appointed candidate through their honorarium. In addition to this honorarium, the appointed candidate will be offered shared office space in the University and will be able to use the University Libraries and other facilities.

The University will provide the fellowship holder with insurance coverage for injury and/or for damages to third parties incurred in the execution of research activities.

Art. 4 - Duties of Visiting Fellow

The Visiting Fellow will be expected to engage in the research outlined in their application, and to deliver a lecture or a seminar during their tenure. The Visiting Fellow will also be expected to participate in the intellectual activities of the Department and the Ca' Foscari University in general, and to acknowledge the Department and INSTAP in any publications emerging from her/his research in Venice.

- 1. Completed and signed application form
- 2. A statement of the research project to be carried out during the Fellowship (maximum of 1,000 words)
- 3. A short CV (maximum 8 sides of A4, using a font of 12pt size minimum)
- 4. copy of an identity document

No references are required.

Closing date for applications: 1 pm (Central European Summer Time) of June 17th 2024

Art. 6 - Selection Committee

The Selection Committee is composed by three professors of Ca' Foscari University of Venice.

Art. 7 - Publication of the selection results

The selection results of the application call will be published on the websites of the Department of Humanities and of the CeSAV.
