



## Notice for financial support to international mobility, 2024/25 – 1<sup>st</sup> call for students whose mobility starts in year 2024

Ca' Foscari International College acknowledges dedicated funding from MUR DM 231/2023 and offers financial support to Ca' Foscari International College students who will be abroad during the academic year 2024/25 within the framework of their international mobility requirement.

### 1. Scope

Only Ca' Foscari College students enrolled in the second or third year of their BA or in the second year of their Master and 1st year MA students who had been College students in their BA can apply.

### 2. Purpose

College students can be effective ambassadors who first-hand attest and disseminate the benefits of the multidisciplinary education offered by the system of Italian University Honors Schools (Scuole Superiori di Ateneo). During their mobility abroad, they can promote the International College and the associated network of Honours schools in their host institution and in the foreign country they are visiting.

The lump sum listed in the attached table is used to subsidize the students' compulsory mobility abroad, in exchange for the recipient's effort to divulge the activities and enhance the visibility of the system of Italian University Honors Schools and the International College among prospective candidates.

### 3. Financial support

The financial support is offered as a lump sum to partially cover travel and subsistence expenses of the recipient during their stay abroad. Funds are assigned based on the actual mobility duration.

The lump sum is computed as follows. Foreign countries are partitioned into three categories (A, B, C) with a conventional base amount:

A: 20 euro per diem

B: 25 euro per diem

C: 35 euro per diem

For the first 60 days abroad, the base amount is multiplied by a coefficient that takes into account the proximity of the destination to Venice: this is 1 for destinations up to 1,500 km away, it is 2 between 1,500 and up to 3,000 km, and it is 3 above 3,000 km. After that, the base amount applies.

The final per diem is the minimum between the adjusted amount and 50 euro.

For example, if a student plans to spend 90 days in an A-category country that is more than 3,000 km. away, the lump sum will be  $60 \cdot [\min(20 \cdot 3, 50)] + (90 - 60) \cdot 20 = 3,600$ ; if a student plans to spend 45 days in a B-category country that is 2,000 km away, the lump sum will be  $45 \cdot [\min(25 \cdot 2, 50)] = 2,250$ .



All the aforementioned amounts are to be intended before taxes (gross amount).

As per art. 5 students are expected to act as College ambassadors consistently with the purpose of the initiative.

#### **4. How to apply**

An eligible College student has to apply by filling all the requested information in the electronic form (<https://forms.gle/PUq3HQcWmx7rXFzY7>). Any failure to dutifully and truthfully complete the required form will prevent getting financial support.

Please take good note that the information provided is under your responsibility as per art. 46-47 of the Presidential Decree 445/2000. In case of false declaration or disrespect of the duties listed below financial support will be reclaimed and disciplinary action may follow.

#### **5. Duties**

The International College will pay upfront the whole lump sum by the end of 2023 to applicants who:

1. fill in the request as indicated in art. 4 (it is required to upload travel tickets as evidence for the actual number of days of the mobility):
2. commit themselves to provide detailed evidence with a written report at the end of the mobility period of having taken at least one of the following actions:
  - promotional/dissemination meetings with students or teachers at the host institution or in the Italian Cultural centers or in at least one high school in the host country;
  - promotion of the College through social platforms at hand, also in network with other Italian Scuole Superiori di Ateneo, in English or in the language of the host country;
  - further actions proposed by the student and approved by the International College Director.
3. The report must be sent to [collegio.internazionale@unive.it](mailto:collegio.internazionale@unive.it) no later than 15 days after the end of the mobility.

Missing any of these conditions is sufficient cause for a total refund of the received sum by the applicant.

#### **6. Deadline**

Applications must be submitted by **October 6th, 2024**.
