Use this registration form:

- if you are **over the age of 18** and you want to access the libraries and book services, even if you are not a Ca' Foscari University of Venice member (student, teacher, researcher, technical-administrative staff, etc...)
- if you want to **renew your registration** to the University Library System.

Membership is **free** and is **valid for one year**.

After have filled all the fields, send **the form with a copy of an identity card** by email to **one of the following libraries** (choose the library you plan to go to most often; the registration and the card are valid in all Ca' Foscari libraries):
