



Italian National Health Insurance for students

Find below useful information about the **Italian National Health Insurance** *Servizio Sanitario Nazionale* – SSN (<https://www.aulss3.veneto.it>).

The National Health Insurance allows you to access all the benefits of the public service, which include (some of them may require the payment of a fee, the so-called “ticket”):

- General Practitioner or pediatrician;
- Hospital recovery at the public hospitals;
- Pharmaceutical aid;
- General medical examination in clinics;
- Specialized medical examination.

USEFUL INFORMATION:

- In case of a health emergency, you can go to the first aid station of the closest hospital even if you did not purchase any insurance (in this case, please remember that you might have to pay a fee).
- If you are EU citizen, your EHIC (European Health Insurance Card) is valid in Italy, but you can use it for emergencies only. If you want to be fully covered, please follow these indications. Please be informed that, in order to enrol to the national insurance, you must move your residency in Italy.
- The Italian Health Insurance (SSN) is valid **ONLY** in Italy, not in Europe.
- If you live in another Italian Region (not Veneto) you must apply in the another region

The emergency number 118 is free and available 24H



How to register in the National Health Insurance (2 STEPS)

As a student, you have to refer to the Voluntary Registration (*iscrizione volontaria*). Please, notice that **the registration is valid for a calendar year** (from January to December) and the fee amount does not change. Anyway, it is possible to pay in advance the next solar year enrolment.

Example: if you arrive in September, you should pay the fixed amount and you will have the cover until December 31st. On January 1st of the next year, or even before paying in advance, you must renew the insurance paying the same amount.

1 STEP - Pay for the registration (at the Post Office):

Go to a post office and ask for a “bollettino postale”. Fill in the little form (white and red) that the post officer will give you as follow:

STEP 2 – Apply for registration (at Local Health Company – Administrative offices):

For the registration you will need to go to the closest “ASL - Ufficio Anagrafe” (Local Health Company – Administrative Office).

Required documents:

- “bollettino postale” payment receipt (STEP 1),
- Valid ID card or passport;
- Official Tax Code (registered at Tax Agency - Agenzia delle Entrate);
- Accommodation contract (registered at Tax Agency) or Declaration of Hospitality;
- Certificate of Enrollment at Ca' Foscari University.
- For non-EU students: residence permit (or post office receipt);
- For EU students: certificate of residence in Italy, (*)

* If you are a citizen of the European Union, you must move your residence to Italy. For more information, please contact the EU citizens office (“Ufficio Comunitari”) of your district.
