"EMOTIONAL COMPETENCES AND PERSONAL DEVELOPMENT" – CA' FOSCARI COMPETENCY CENTRE [PLM003].

Deadline Monday 9 December 2024

ARTICLE 1 - PRESENTATION AND PURPOSE

- 1. Starting with the 2024-2025, the University has launched the "Emotional Competencies and Personal Development" course [PLM003] (hereafter Competency Development) which is taught in English and aims at developing the behavioural competencies of Master's degree students through highly interactive teaching methods. Students will be supported towards the awareness of their individual characteristics, in order to improve the match between the competencies owned and the expectations of the labour market given by companies operating in different sectors.
- 2. Competency Development provides 30 classroom hours corresponding to 6 ECTS credits. The activities will take place in the third term (3 February 2025 15 March 2025, including any recovery classes) with the following topic breakdown:

- 3. Competency Development provides the following opportunities:
 - bring students closer to the logic, language, processes and expectations of the labour market, increasing their *employability*. Consistent with the fact that the selection processes, in every field of employment, are now strongly guided by the assessment of candidates' behavioural competencies, the course will enable participants to acquire the tools to bring their profile closer to the demands of the labour market;
 - create cross-disciplinary learning experiences between students enrolled in different master's degree courses, fostering processes of interaction and mutual contamination;
 - enrich the opportunities for learning behavioural competencies in a manner consistent with other initiatives activated on the same theme by the University.
 - 4. Competency Development is one of the educational proposals realised within the Ca' Foscari Competency Centre (www.unive.it/cfcc), which carries out research, training and consultancy activities in the field of the development and evaluation of behavioural competencies (*soft skills*). The main objective of the Ca' Foscari Competency Centre is to increase the performance and labour market attractiveness of individuals through the development of their soft skills portfolio.

ARTICLE 2 - RECIPIENTS AND ADMISSION REQUIREMENTS

- 1. There are 60 places available. Access to Competency Development is subject to selection, according to the methods indicated in this article and in the following art. 4
- 2. Students **enrolled in a Master's degree course** at Ca' Foscari University Venice in the **academic year 2023-2024** and with a **maximum age of 30 years not yet completed** may participate in the selection.
- 3. Students who have already participated in the Competency Lab (AM0006), Competency Lab English (AM0008) and Competency Lab Plus (AM0007) of the Ca' Foscari Competency Centre cannot apply.

ARTICLE 3 - SUBMISSION DEADLINES AND MODALITIES OF PARTICIPATION

- 1. To participate in the Competency Development, recipients referred to in Article 2 must fill in the application form available online at https://www.unive.it/pag/31171/. The form will be available from 12 noon on Monday 28 october 2024 and must be completed by 12 noon on Monday 9 December 2024.
- 2. Applications will be automatically excluded if they are found to be:
 - a) received after the deadline;
 - b) incomplete or incorrect;
 - c) not written on the online form provided by the University;
 - d) containing untrue statements.

Applicants who have already participated in Competency Lab (AM0006), Competency Lab English (AM0008) and Competency Lab Plus (AM0007) or who participate in them in the months following the application deadline will also be excluded.

- 2. Candidates will be admitted on the **basis of the order of application**, limited to the places available in each area. For this purpose, the date and time of submission of the online form resulting from the system will be considered.
- 3. Candidates from the "Venetian Erasmus" programme will only be included if one of the areas has vacancies.
- 4. Should any vacancies arise in an area, even after the insertion of students from the "Venetian Erasmus" programme, they will be assigned among all those who have sent in their applications using the form referred to in Art. 3 paragraph 1, according to the general order in which the applications were received. The list of those admitted will be drawn up by the Educational Programmes Office.
- 5. The list of eligible candidates will be published by **Friday 13 December 2024** on the Ca' Foscari University Venice website (https://www.unive.it/pag/31171/). At the same time, a publication notice will be sent to all students who have applied.
- 6. No later than 12 noon on **Friday 20 December 2024**, candidates must send an e-mail to competencydevelop@unive.it to confirm or deny their willingness to participate in the course.
- 7. In the event of withdrawal or non-confirmation by an admitted student, candidates will be admitted according to the selection criteria set out in paragraph 2 of this Article.
- 8. The final class composition will be published on Friday 10 January and interested parties will be notified by e-mail.
- 9. In case of cancellations after the publication of the class, eligible candidates will be contacted by email and may request to participate by writing to competencydevelop@unive.it. Candidates will be admitted on a first-come, first-served basis.

ARTICLE 5 - FREQUENCY

- 1. Selected students are obliged to attend the course activities.
- 2. Students who have exceeded 20% absence will not be admitted to the final examination.
- 3. Attendance at CESI is incompatible with participation in the Competency Lab (AM0006), Competency Lab English (AM0008) and Competency Lab Plus (AM0007) of the Ca' Foscari Competency Centre.

ARTICLE 6 - RECOGNITION OF CREDITS

1. Competency Development may be recognized as an elective or supernumerary exam. Competency Development may be also recognized as a substitute internship activity only with the prior approval of the Teaching Committee, in accordance with the <u>Guidelines for innovative and integrated teaching activities</u>

University credits will be acquired upon passing the final exam. The grade will be awarded by evaluating the course work (individual assignments) and the outcome of the final exam.

2. Further guidance on the inclusion of the activity in the study plan will be provided during the course.
