#### Art. 1 - Scope

- 1.1. The Department of Economics of Ca' Foscari University of Venice and the Henley Business School of the University of Reading (UK) are partners in the framework of a dual degree programme. The two institutions intend to promote the participation of their students in the first edition of the Summer School in Sustainability in the Business World, which will take place in San Giobbe Campus from July 1st to July 12th, 2024. The Summer School is jointly organised by the two Universities.
- 1.2. Programme and contents of the Summer School in Sustainability in the Business World are published at the webpage <a href="www.unive.it/icmasummerschools">www.unive.it/icmasummerschools</a>. Classes are held in **English** and take place **on campus**.
- 1.3. Participation in the Summer School in Sustainability in the Business World is free of charge.
- 1.4. Selected students will have the opportunity to attend classes with the students from the Henley Business School of the University of Reading.
- 1.5. **25 places** are available for the 2024 edition of the Summer School in Sustainability in the Business World. This call for application outlines the admission procedures.

## Art. 2 - Admission requirements

- 2.1 Students regularly enrolled for the 2023/24 academic year in the Master's degree programmes in Economics and Finance (Economia e Finanza), Economics, Finance and Sustainability, Data Analytics for Business and Society or Global Development and Entrepreneurship at Ca' Foscari University of Venice can apply for admission to the Summer School in Sustainability in the Business World. Students must be up to date with the payment of tuition fees for the 2023/24 academic year by the application deadline.
- 2.2 Students must also have a **B2 level proficiency in English**.
- 2.3 Priority will be given to students selected during the 2023/24 academic year for the dual degree programme with the Henley Business School of the University of Reading, whose mobility is scheduled for the 2024/25 academic year.

#### Art. 3 - Application procedure

3.1 Students must fill in the **Google form** mentioned below:

no later than <u>Monday</u>, <u>June 10<sup>th</sup></u>, <u>2024 at 12:00 PM CET (noon)</u> in order to apply for the Summer School. The form must be filled in electronically in its entirety and does not require to be signed.

- 3.2 Candidates must also attach the documents mentioned below to the application form within the Google form, under penalty of exclusion from the selection procedure:
  - a self-declaration of enrolment in their degree programme with exams (students
    can download it from their reserved area under Certificati S3 > Autocertificazione
    Iscrizione con Esami), dully dated and signed;
  - a curriculum vitae in European format, dully signed;
  - a motivational letter;
  - a valid copy of their ID card or passport.
- 3.3 The documents mentioned on Article 3.2 can be submitted in either Italian or English language.
- 3.4 Applications that are incorrectly completed, incomplete, submitted after the deadline for application, not completed using the designated form, or containing false statements will not be considered.
- 3.5 A specific note will be published at the webpage <a href="www.unive.it/icmasummerschools">www.unive.it/icmasummerschools</a> in case of an extension of the application deadline.

### Art. 4 - Selection procedure and ranking list

- 4.1. The selection procedure will be carried out by an Examination Committee composed of:
  - Professor Monica Billio, faculty member of the Department of Economics, acting as Chair of the Committee;
  - Professor Michele Costola, faculty member of the Department of Economics, acting as a member of the Committee:
  - Dr. Davide Gallo, technical-administrative staff of the Educational Programmes Office
    of the Department of Economics, acting as Secretary of the Committee.
- 4.2. Candidates will be evaluated by the Examination Committee based on their academic curriculum attached to the application procedure. The Examination Committee will draw up an admission ranking list to the programme.
- 4.3. The admission ranking list will consider the following criteria:
  - number of academic credits earned and recorded by the application deadline;

- GPA by the application deadline;
- transversal skills and other competencies documented in the candidate's curriculum vitae and motivational letter.
- 4.4. Additional points will be awarded to the students who have been selected in the 2023/24 academic year to take part to the dual degree programmes offered with the Henley Business School of the University of Reading for the 2024/25 academic year.
- 4.5. In the event of a tie between candidates, the student with a higher GPA by the application deadline of this call will be preferred. In case of further tie, the younger candidate will be preferred.
- 4.6. The first 25 candidates in the admission ranking list will be admitted to the programme, while those who exceed this number will be considered eligible.
- 4.7. The admission ranking list will be published at the webpage www.unive.it/icmasummerschools.

#### Art. 5 – Acceptance procedure

- 5.1. Admitted students must send an acceptance statement of participation via e-mail to <a href="mailto:didattica.economia@unive.it">didattica.economia@unive.it</a> within three days from the publication of the admission ranking list.
- 5.2. Failure to comply with these obligations or in the event of withdrawal will result in the automatic invitation of the next eligible students in the ranking list to participate in the Summer School.
- 5.3. Admitted students will be promptly notified in the event that the Summer School will not be activated.

# Art. 6 - Provisions regarding credit recognition

6.1. Participation in the Summer School in Sustainability in the Business World **does not** entail the recognition of credits in the student's academic career nor the awarding of bonus points towards the calculation of the final graduation grade.

### Art. 7 – Responsible Officier for the administrative procedure

7.1. The Responsible Officer for the administrative procedure, pursuant to Law No. 241/1990, is the Secretary of the Department of Economics, Engr. Silvia Lovatti.

#### Art. 8 - Personal Data Processing and Confidentiality
