PRE-ENROLMENT APPLICATION ON UNIVERSITALY for bachelor's and master's degree candidates

Applicants are invited to visit the [Pre-enrolment and visa application](#) webpage of Ca' Foscari University of Venice for all the relevant information.

After sending the pre-enrolment application, the **university staff will check the applications received via the Universitaly portal** to indicate the final result of the pre-evaluation process carried out previously on the **university's online application portal**, specifying whether they have been accepted or conditionally accepted.

How to send the pre-enrolment application on Universitaly

Visit the official webpage www.universitaly.it and register on the portal on this webpage by clicking [Pre-enroll now](#).

You can switch to **English/Italian language** on the top right of the webpage.

Fill in the fields required to **create your profile** and remember to:

- Enter your **personal information** exactly **as presented in your passport AND on apply.unive.it**. For example, if you have 2 or more names/surnames displayed on your passport, you must write down all of them;
- Only use the **email address with which you registered on Ca' Foscari's online application portal**. If you use a different email address, we won't be able to identify you and the application will be rejected;
- The self-generated Italian tax code (codice fiscale) in your apply.unive.it profile is not official. If you do not already have an official tax code, do NOT write it down. The official one will be issued to you once the university enrolment procedure has been completed.

Click on "New pre-enrolment application" to start an application. You can stop and continue to fill it in as you prefer. To continue the application click on "Go to application".

You can pre-enrol once to one University and one course.

In order to find your course, you need to select the proper course type. Please check with the university you would like to apply to the correct selection you need to opt. The course type is in Italian only.

In case you need to modify the application after you have submitted it please contact the University directly, they will check your request and eventually reopen the application.

For any further information about courses, documents, next step of the procedure please contact the University you are applying to.

In order to update your personal data, you need to contact [Technical support](#) specifying your correct data, indicating them completely and attaching copy of your passport.

STEP B:

- **check your passport information**
- **upload a photo** (passport size) and a scanned **copy of your passport**
- indicate at **which Embassy/Consulate** you will apply for a visa
Remember you can select the offices both in your home country or in the country where you are officially residing.
- indicate **the reason** (prospective students should select: **"I want to enrol in a study programme"**)
- select **"Università "Ca' Foscari" VENEZIA"**
- select **one programme for which you received the letter of eligibility** for enrolment as well as the curriculum, where available (it is recommended that you not filter the courses by teaching language, so that the curricula are visible)
- If you have been accepted for multiple courses, you must choose one in this moment
- You do **NOT** need to enter "Identification account at the chosen University/AFAM/Institute"

STEP C:

- Upload the **academic qualification certificates** and supporting documents that you provided for your pre-evaluation on Ca' Foscari's online application portal:
 - final diploma (if available) or provisional certificate - copy of original and Italian/English translation (where necessary)
 - certificate showing the exams taken - copy of original and Italian/English translation (where necessary)
 - language certificate(s) (where required)
 - CIMEA Statement of Comparability/Declaration of Value/Diploma Supplement (where held)

Important: As far as our institution is concerned, the **only mandatory document** to be uploaded to your pre-enrolment application is **your passport**, as all the other documents which are mandatory at this stage have already been provided in your online application on apply.unive.it. However, you will have to provide the Embassy/Consulate with the necessary documents when you address them for the visa application. Please check their website or refer to them directly to inquire about specific requirements they might have.

SUMMARY:

- Check your details, read the declarations and submit the pre-enrolment application

The undersigned declares

- enrolment in higher education institutions in Italy is governed by specific procedures issued by the Italian Ministry for Universities and Research, published annually on the website www.studiare-in-italia.it/studentistranieri;
- to enrol in study courses, it is necessary to follow the instructions provided by the higher education institution responsible for the chosen course and complete the related procedures, which do not necessarily end with the completion of the pre-enrolment phase;
- the pre-enrolment procedure and this "pre-enrolment application" do not in any way replace the admission and enrolment procedures for the chosen course, which will be completed in the phase following the issue of the visa for study purposes, after verifying the authenticity of the documentation produced, and also does not imply any claim or automatic acceptance for the purpose of issuing the relevant visa for study purposes;
- issuing the visa is the exclusive responsibility of the competent diplomatic-consular missions, after verifying that they meet the requirements mandated by current legislation;
- in the "pre-enrolment application", the persons authorised to process the data are empowered to rectify any errors in the transcription/transliteration of personal data, verifying the latter with the data shown in the passport provided;

he/she undertakes to:

- provide proof of the pre-determined necessary financial resources and the necessary insurance coverage for medical treatment and hospitalisation in accordance with the provisions of Italian law or to commit to enter into a contract for such insurance coverage upon entry into Italy;
- forward the application for a STUDENT residence permit to the competent police headquarters within 8 working days of entry into Italy, complete with the required documentation;
- return to the country of residence upon expiry of the visa if not admitted to or not enrolled in the chosen course.
